Department of Health Promotion and Physical Education is part of the Wellstar College of Health and Human Services. Kennesaw State University is a comprehensive university with 11 colleges located in Kennesaw and Marietta, northwest of metro Atlanta. KSU is a member of the University System of Georgia and the second largest university in the state and offers undergraduate, graduate and doctoral degrees to its more than 50,000 students. The institution is currently a Carnegie-designated doctoral research institution (R2) which has Research one aspirations.
